### Budget

- The state faced a \$1.2 billion budget shortfall for FY 2025-2026.
- Municipalities saw approximately \$140 million in local government grant funding swept to balance the budget.
- Depending on Federal actions, there may be a special session called to re-balance the budget.
- The budget outlook is similarly bleak for FY 2026-2027.

- HB25-1030 Accessibility Standards in Building Codes
  - IBC and ADA standards
  - At adoption or amendment of new building code (not energy code)
- HB25-1152 Tech Accessibility Liability Contractor
  - Mandatory contract provisions for digital accessibility compliance

### Beer & Liquor

• SB25-033 - Prohibit New Liquor-Licensed Drug Stores

SB25-132 - Spirituous Liquor Manufacturer Tastings Conducted

# Building Codes

- HB25-1060 Electronic Fence Detection Systems
  - Alarm system permitting
  - Residential limits
- HB25-1077 Backflow Prevention Devices Requirements
- HB25-1273 Residential Building Stair Modernization
  - Jan. 1, 2027 in cities with 100,000+
  - 5 stories, 4 units per story

#### Criminal Justice

- HB25-1087 Confidentiality Requirements Mental Health Support
- HB25-1112 Local Authorities Enforce Vehicle Registration
- HB25-1114 Defense Review of Tangible Object for Criminal Trial
  - Defense counsel right to view tangible criminal evidence
  - Prohibits use of body-worn cameras by law enforcement

#### Criminal Justice

- HB25-1136 Peace Officer Conduct Database
- SB25-009 Recognition of Tribal Court Orders
- SB25-310 Proposition 130 Implementation
  - 10-year funding formula
  - Certification requirements to obtain funding
  - Reporting via annual audit or separate report if exempt from audits

#### Elections

- SB25-001 Colorado Voting Rights Act
  - Voter suppression
    - "Material disparity"
    - Burden-shifting framework
  - Voter dilution
    - "Polarized voting" or "totality of the circumstances"
  - Gender and confinement protections

#### Elections

- SB25-001 Colorado Voting Rights Act
  - Process
    - Standing
    - Pre-suit notice & option to modify practices
    - Judicial authority
      - To modify state or local law
      - No deference to local solution
  - Reporting
  - Multi-lingual ballot options in municipal elections

#### Elections

- HB25-1225 Freedom from Intimidation in Elections Act
  - Similar to Federal Voting Rights Act
  - Firearm presumption of intimidation and law enforcement exception

### Employment

- HB25-1031 Law Enforcement Whistleblower Protection
  - New cause of action for law enforcement whistleblowers
  - Exhaustion of internal administrative procedures
  - Training or notice
- HB25-1300 Workers' Compensation Benefits Proof of Entitlement
- SB25-144 Changes Paid Family Medical Leave Insurance Program

#### Finance

- HB25-1224 Revised Uniform Unclaimed Property Act Modifications
  - Eliminates local government exemption option
- SB25-023 Local Government Audit Exemption Thresholds
- SB25-268 Changes to Money in the Marijuana Cash Tax Fund

# Housing

- HB25-1272 Construction Defects & Middle Market Housing
  - Fast track process (like Prop 123) for affordable condos

- SB25-002 Regional Building Codes for Factory-Built Structures
  - Preemptive state regulation of construction and inspection
  - All structure types
  - Limit on more "restrictive standards" than comparable structures

• SB25-313 - Proposition 123 Revenue Uses

# Immigration

- SB25-276 Protect Civil Rights Immigration Status
  - Prohibitions on state employees extended to political subdivision employees
  - Injunction and civil penalty for violations
  - Requirements for other entities including public libraries

#### Land Use

- HB25-1056 Local Government Permitting Wireless Telecommunications Facilities
  - 90 & 150 day "shot clocks" for all wireless facilities
  - Unpermitted non-substantial changes
- HB25-1093 Limitations on Local Anti-Growth Land Use Policies
- HB25-1096 Automated Permits for Clean Energy Technology
- HB25-1169 Housing Developments on Faith and Educational Land (YIGBY - Yes In God's Back Yard)

### Misc. Governmental Operations

- HB25-1029 Municipal Authority Over Certain Land
- HB25-1208 Local Governments Tip Offsets for Tipped Employees
- HB25-1295 Food Truck Operations
- SB25-050 Racial Classifications on Government Forms
- SB25-146 Fingerprint-Based Criminal History Record Checks

### Municipal Courts

- SB25-062 Failure to Appear Charges in Municipal Court
- HB25-1147 Fairness & Transparency in Municipal Court

### Municipal Liability

- HB25-1239 Colorado Anti-Discrimination Act
  - Equalized damages include actual & non-economic damages
  - \$50,000 cap on non-economic damages with corrective action
- HB25-1312 Legal Protections for Transgender Individuals
  - Discriminatory deadnaming or misgendered publication by place of public accommodation

### Special Districts

- HB25-1219 Requirements for Better Understanding Metropolitan Districts
- HB25-1289 Metropolitan District Leases & Property Tax Exemptions

#### Taxation

- HB25-1247 County Lodging Tax Expansion
- SB25-046 Local Government Tax Audit Confidentiality Standards

### Transportation

- HB25-1039 Commercial Vehicle Muffler Requirements
