FORMULATE A STRATEGY

DEVELOP A LIST OF PROJECTS

- FIND POTENTIAL FUNDING OPPORTUNITIES
 - Grants (All)
 - State-funded programs
 - SDOT formula federal funding
 - Other stakeholders/agencies
 - Innovative financing (PPP, TIFIA, bonds)

GET PREPARED

If you haven't prepared and the NOFO hits the street.....

You'll find yourself behind the 8-ball!

GET PREPARED

Get Familiar With the Program Requirements


- Review previous NOFOs & Grant Agreement Language
- Perform an Assessment of Processes, Procedures, and Systems
 - Financial Management Systems (2 CFR 200.302)
 - Internal Controls (2 CFR 200.303)
 - Bidding/Procurement (2 CFR 200.317-327 or other)
 - Environmental Review (NEPA Regulations, etc.)
 - ROW/Uniform Act (49 CFR Part 24)

Review Your Single Audit (2 CFR 200 Subpart F)


Communicate, Communicate!

State Department of Transportation, Legal Counsel, and Congressional Team


WRITE THE GRANT



Familiarity with the Project



Provide Data and **Analysis**



Write a Compelling Story



Designate a Champion!

BUILD A TEAM

WRITE THE GRANT

Fully address ALL criteria in the NOFO

Be careful of "Insider bias"


Put yourself in the reviewer's shoes

Clear and Concise - Make Yours Stand Out

Solidify the Project Estimate

EXECUTE THE GRANT

- Be ready to get started immediately!
 - O But don't incur costs!



- Period of Performance (2 CFR 200.344)
 - Start date nothing eligible before
 - End Date no cost eligible after
 - Close-out within 90 days (Final acceptance and voucher)
- Execute the grant agreement
 - Consider the SDOT as a pass-through

EXECUTE THE GRANT

- Records Retention (2 CFR 200.334)
 - FHWA Example

REPAY FUNDS!

- No Records
- Not Following Requirements

COUNT THE COST

PROS

- Additional Funding
- Fills Funding Gaps
- Frees Up Other Funds
- Attention to Needs-Locally, Regionally, Nationally

CONS

- Federalizes Project
- Performance Monitoring
- Reporting/Invoicing
- Time (\$ to Materialize/Project to Start)
- Effort/Cost.....

Identify	Ongoing		?
Write	10 hours	100 hours	?
Administer (per month)	Several hours	Several days	?

CONTRACTS AND PROCUREMENT REQUIREMENTS

Grant Review (Pre-Application/Award)

- Review early
- Big issues
- Awareness
- Build relationship

Pre-Grant Agreements

• (e.g. on call agreement for debris removal; FEMA eligible)

Accepting/Executing the Grant

- State of CO Small Dollar Grant Award Terms & Conditions
- IGA

CONTRACTS AND PROCUREMENT REQUIREMENTS

Contractor agreement

- Procurement/solicitation/bid requirements
 - Special provisions and clearances
 - Standardized terms included in solicitation
 - Confirm accurate forms and requirements
 - Communicate with CDOT

Contract

- Required verbatim language
- 2 CFR 200 (Appendix II to Part 200) Contract Provisions for Non-Federal Entity Contracts Under Federal Awards


DESIGN PHASE – KEY REQUIREMENTS

Intergovernmental Agreement (IGA) – Must be Executed before Spending Funds

Project Risk Assessment = Oversight Level

CDOT Review Required at Every Milestone - (4-6 weeks typical) (FIR, FOR, Final PS&E)

START IGA & RISK ASSESSMENT EARLY ENGAGE CDOT LOCAL AGENCY REP DESIGN FOR CDOT COMPLIANCE

DESIGN PHASE - LOCAL VS. FEDERAL FUNDED PROJECTS

LOCALLY FUNDED	FEDERALLY FUNDED (CDOT)	
Full Control	Structured process	
Flexible Timing	More review + compliance	
Faster timeline	Federal reimbursement	

DESIGN PHASE – BIDDING REQUIREMENTS



DESIGN PHASE – KEY TAKEAWAYS



Start early – schedule around CDOT's process



Environmental, ROW, and Utility Clearances control timeline



Design with compliance in mind to avoid delays and rework.

MANAGING THROUGH CONSTRUCTION

Document & Management & Organization

- Contractor Documentation & Requests
- Structure Folders for Final Closeout
- B2G/LPC Tracker Manager
- Pay Applications
- Monthly Schedules
- Pay Tracking for Quantities
- OJT/DBE Requirements
- Buy America COCs/CTRs (submittals)
- Inspection Master Tracking for Quantities, Counts and Traffic
- Material Testing Folder & Weekly Meeting Actions

CM Resources & Staffing

 CDOT and federally funded project requirements and compliance increase the resources and documentation strain on the local agency staff.

MANAGING THROUGH CONSTRUCTION

Common Missteps or Misunderstandings

- Bidding Requirements Contractors and Consultants
 - 10% can be included in the Grant to cover consultant fees.
 - RFP for DBE for Consultant
 - Adding Force Account for OJT, DBE
- Funding
 - Partial funding for project
 - Project limits will not be extended by contract; will need to work internally
 - No variance requests for Buy America Chain of Custody or Civil Rights
- Resources & Benefits:
 - CDOT is a resource, and the LA wants to help you succeed
 - Pre-Pre con with LA representation and Project CM Management Team
 - Consultant staff are often hired to come on board to help with the administrative lift and can also be used for additional knowledge and resources that the Agency may not have with current staff.
