

**TOWN OF CRESTED BUTTE
REVOCABLE FURNISHING ZONE USE PERMIT
2020 APPLICATION**

This application applies only to the sidewalk's furnishing zone (brick area or grass parkway) fronting the applicant's property, and or business.

Use of the furnishing zone is being allowed for adjacent commercial properties due to the social distancing requirements currently imposed during public health orders related to COVID-19. Permits may be revoked by the Town at any time in response to evolving health orders or use of Elk Ave.

The Town's review of this application will focus on sightlines, safety, access, walkway continuity, town maintenance and the accommodation of social distancing. Only layouts approved with this application may be placed in the furnishing zone. Modifications to the layout will require a new application and approval.

Tents, awnings or umbrellas will be considered on a case by case basis.

Under no circumstances may this usage encroach into the sidewalk's concrete walkway along Elk Ave. Items may be placed on the grass parkway areas between walkways and Elk Ave if it

causes minimal impact. Consumption of alcohol is currently not permitted on the sidewalks or within the Elk Avenue right of way including the furnishing zone (brick pavers) unless a temporary modification of premises has been approved for your business by the Town and State of Colorado.

Any use of the furnishing zone must comply with all relevant public health orders issued by the State of Colorado, Gunnison County and Town of Crested Butte.

- Please note, the holder of a license which authorizes the licensee to go upon public property shall indemnify and hold harmless the Town, its officers, employees and agents against any and all claims arising from any occurrence occasioned by the licensed use, and shall maintain, during the period of the license, comprehensive general public liability and property damage insurance, naming the Town, its officers, employees and agents as insureds; providing that the insurance is primary insurance, and no other insurance maintained by the Town will be called upon to contribute a loss covered by the Town; and providing for thirty (30) days' notice of cancellation or material change to the Town.
