The meeting was called to order by President Massey at 3:40 p.m. Attendance was taken and a quorum was established.

President Massey welcomed everyone then the Board and staff members introduced themselves.

CML staff members were excused temporarily, as the Board moved into Executive Session to select their officers. When the full meeting reconvened at 4:12 p.m., the new officers for 2025-2026 were announced: President Seth Hoffman, Vice President Laura Weinberg, and Secretary/Treasurer Carol Saade. Wynetta Massey moved to the Immediate Past President position.

Anna Stout MOVED AND Michelle Eddy SECONDED A MOTION TO APPROVE THE MINUTES FROM THE MAY 2, 2025 MEETING. The motion passed unanimously.

Executive Director Kevin Bommer congratulated the newly elected board members and encouraged them to participate in the upcoming New Board Member Orientation. He also reviewed the schedule for the July Board Retreat in Grand Junction.

Board members were asked to review and update their board member information sheets.

Allison Wright, Finance and Administration Manager, provided an update on CML Banking Resolutions and Authority to Update Signatures on the CML banking accounts and requested Board approval.

Liz Hensley MOVED AND Wynetta Massey SECONDED THE MOTION TO APPROVE THE CML BANKING RESOLUTIONS AND AUTHORITY AS PRESENTED. The motion passed unanimously.

Kevin Bommer described the duties of the Budget, Audit and Management (BAM) Committee. There are six members: the secretary/treasurer who chairs the committee, the vice president as a non-voting member, and four other Board members appointed by the president. Bommer requested that any Board members interested in serving on the committee should contact President Hoffman, who will make the appointments and announce the appointees later.

General Counsel Robert Sheesley summarized the Amicus Participation Report and gave an update on current work with the City of Boulder, City of Lakewood, City of Aurora, and the City of Westminster.

Bommer gave a brief overview of the first half of 2025, with some focus on attempts to improve the partnership with Gov. Polis. Dan Kramer voiced a desire for the league to be more proactive rather than predominantly defensive.

The following dates were approved by President Hoffman for the upcoming Board meetings: 2025: September 12, October 24, and December 12. 2026: January 23, February 27, March 27, and April 24

Mayor Josh Rivero, Mayor Laura Weinberg, and Mayor Rachel Medina gave a brief overview of their interview with Kyle Clark airing the evening of June 26th on Next with Kyle Clark, 9NEWS.
