
- Task 1: Project Start-up, Baseline Conditions
 - Kick-off Meeting and Scope of Work Development
 - Economic Base and Labor Force Trends
 - Housing Gaps Analysis
 - Existing Housing Inventory Compared to Need
 - Deed-restricted and Naturally Occurring Affordable
 - Patterns of Growth and Demographic Change

- Task 2: Primary Housing Market Research
 - Housing Stakeholder Interviews
 - Patterns of housing investment;
 - Housing development costs and barriers;
 - Demographics and Motivations of Buyers and Renters; and
 - Factors/policies that effect the development of market-rate and affordable housing.
 - Community Housing Survey

- Task 3: Housing Needs Projections
 - Future Households and Employment in Golden (10-year projection)
 - 10-Year Housing Needs Projections
 - Housing needs by type of housing unit, tenure, and price point
 - Identify gaps in future housing production relative to future need by price range or affordability level

- Task 4: Economic Analysis of Housing Development Alternatives
 - Housing Prototypes
 - Housing Development opportunities based on representative sites (amount and type of housing).
 - The type of housing that could be developed on representative sites given assumptions about land area, housing density, parking requirements and other factors that influence housing development.

- Task 4: Economic Analysis of Housing Development Alternatives
 - Real Estate Economic Analysis
 - Future housing needs which can be addressed by market-rate development;
 - Housing production gaps in the absence of subsidies or incentives; and
 - The impact of construction costs, regulatory requirements, municipal impact fees, and other factors on housing affordability in Golden.



- Task 5: Draft and Final Report and Presentation
 - Draft Report, Strategies, and Policies
 - Presentation to Council in early September 2022
 - Review and input by Planning Commission, GURA and the Golden Chamber of Commerce
 - Final Report & Presentation
 - Feedback incorporated and final adoption --October 2022


Land use regulations make new

Future of Housing Work

- Adoption of the Plan (October 2022)
 - Creation of an Affordable Housing Trust Fund
 - Appointment of an Affordable Housing Committee
 - Review the Housing Needs and Strategies Assessment
 - Review existing City policies, programs, and regulations relevant to the development, cost, and availability of housing
 - Recommendations to City Council regarding the priority areas of focus for housing development and preservation
